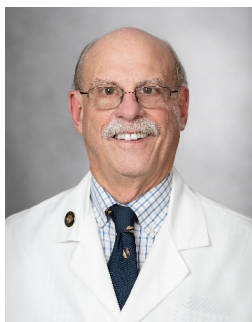




An Endowed Chair in Honor of Dr. Thomas Moore

Thomas Moore, MD, is a maternal-fetal medicine specialist. He provides prenatal care for women with high-risk pregnancies and is recognized nationally as an expert on pregnancy and diabetes. Dr. Moore has been ranked multiple times as one of the top obstetricians and gynecologists in the nation by U.S. News & World Report, as well as having been named repeatedly as a "Top Doc" in San Diego Magazine's "Physicians of Exceptional Excellence" annual survey performed in collaboration with the San Diego County Medical Society. Most recently, he received the Louis M. Hellman MD Midwifery Partnership Award from the American College of Obstetricians and Gynecologists.

Dr. Moore embodies his values of compassion, empathetic care and service. In addition to his excellence as a clinical care provider, he has made a profound impact on the lives of his patients, peers and mentees, setting the standard for all the providers he works with.
